- 1818, N-3. Obverse <u>brockage</u> struck 20% off-center. The date shows fully. Good-4.
- 140. 1826, N-5, Close Date. Overstruck on the lower obverse edge by the reverse of another large cent, thereby producing a TAT and half of the E on this specimen; extremely fine but some fine corrosion on both obverse and reverse. Very Fine-30.
